#### **Health and Safety**

#### **Confidentiality and Sensitive Information**

Information is one of our most valuable assets. DIRAK is committed to protecting information whether it belongs to us, another company or another person. This is essential to our success, reputation and sustainability as a company.

#### **Business Integrity**

#### **Prohibition of Child Labour**

DIRAK is committed to respecting the minimum standards set out in the ILO Core Labour Standards. DIRAK undertakes in particular not to employ children. Children are understood to be all persons under 15 years of age. Children may be employed at the age of 14 by way of exception if the law in the country of production allows them to work from the age of 14.

#### Occupational and Plant Safety, Health Protection

DIRAK undertakes to comply fully with all laws for the protection of people and the environment. In order to prevent accidents and personal injury, DIRAK provides safe and healthy working conditions and where required safe conditions that meet the applicable legal requirements as minimum criteria.

#### **Supplier Selection**

DIRAK builds long-term relationships with suppliers who support each other. These business relationships are based on the principles of trust, fairness and loyalty.

#### **Quality Assurance**

DIRAK maintains a quality management system according to DIN EN ISO 9001 and will manufacture and test the products according to the rules of this quality management system.

DIRAK ensures that only flawless products are delivered by carrying out suitable checks as part of its processes (incoming goods, production and outgoing goods).
